Scope of Patient Care

HAC Medical provides a range of medical transport services on a 24-hour basis, which includes dedicated air ambulances, helicopters and ground ambulance services. Our air ambulances are staffed and equipped to transfer critically ill or injured patients, or to transfer patients for palliative care.

Our dedicated air ambulances are geared for a 24-hour operation to selected airfields that fit the minimum requirements for the aircraft type we operate. The air ambulances are fitted with state-of-the-art equipment, including advanced life support drugs, defibrillators, ventilators, advanced invasive and non-invasive patient monitoring equipment, as well as ultrasound machines, blood gas analysing machines and syringe drivers for full Intensive Care Transfers.

Our services offered includes a bed-to-bed transfer. In some cases, a wing-to-wing transfer is conducted. Wing-to-wing transfers are only conducted following certain minimum requirements where we cannot complete a bed-to-bed transfer, and a full transfer indemnity is conducted.

At least one of the above is configured for medivac at all times. Our Helicopter Services are currently limited to daylight only operations, due to the Air Navigation Regulations of Zimbabwe.

Our fixed wing aircraft operate on a 24-hour basis where airports have 24-hour operations, but are limited in certain areas to daylight hours of operation.
